Solid pile 3 year warranty & Service Agreement

1. During the first (2) three years, if any addition adjustments are necessary on existing work, Du-West will complete the adjustments at no charge using the same access points of the original installation. After the third year, at no charge, the property owner will be contacted and offered the option to enroll in the Du-West renewable yearly service agreement.
2. After the 3 year warranty has expired, the yearly fee for the Service Agreement shall be \$250.00 and includes the following:
 - a. Included in the renewal of the Yearly Service Agreement is a complete foundation evaluation of your home and its surrounding property. The evaluation includes a complete drawing of the home with elevation readings and a review of the surrounding property. As a part of this evaluation, Du-West will provide maintenance recommendations.
 - b. If adjustments are needed, they will be performed at the discounted rate of \$175.00 per pile to adjust, \$65.00 each for perimeter breakout, \$190 for interior break thru floor, and \$195.00 per foot to reopening tunneling that was performed during the original installation. All costs are based on 2023 pricing and will be adjusted accordingly for future price increases.
 - c. If the property owner elects to have areas tunneled under the foundation that were not originally tunneled, it will be charged at \$195.00 per foot or the current market rate for solid piles.
3. Once the above is completed, the Service Agreement will take effect for one year.
4. Each year the property owner will be contacted prior to the anniversary date of the Service Agreement and provided the option to renew at a cost \$250.00.
